The Evergreen Art Open - Call for Entries

The Evergreen Artists Association in Evergreen, CO is now accepting submissions for The Evergreen Art Open. Entries need to be received on or before March 10, 2010. Please mail entry form, entry fee, CDs and SASE to: EAA Spring Show, PO Box 735, Evergreen, CO 80437-735.

Eligibility: This show is open to all artists that reside in Colorado, who are 18 years of age or older. All 2D and 3D fine art media is accepted. Artwork must be less than 3 years old and must not have been created with supervision.

2D Work: All mediums accepted. Framed pieces may not exceed 44" in any direction including the frame. Work must be ready to hang (no saw tooth hangers). All artwork must be original. No prints or giclees will be accepted.

3D Work: All work is limited to 3'x3'x3' and must weigh less than 100 lbs. No hanging sculpture, installation pieces or videos will be accepted. All jewelry must be original including beads.

Entry Fees: There is a non-refundable \$30 entry fee for up to 3 pieces. Checks payable to the Evergreen Artists Association.

CD Specification: Digital submissions must be in jpeg format, minimum 300 dpi resolution at 8" x 12". Submit on CD labeled with artist name and address. Name electronic files as follows: lastname_entryno_titleofwork.jpeg. Abbreviate as needed on electronic file name, but be sure the entry form has complete information. CDs of accepted entries will be retained by EAA to be picked up by artist on check-in date below.

Juror: Doug Dawson is a Master Pastelist. He teaches Plein Air painting and a studio landscape class at the Art Students League of Denver. He also teaches painting workshops around the United States. He is the author of Capturing Light and Color with Pastel and is included in many instructional books on pastel painting. He was the 2008 Pastel Society of America's Hall of Fame Honoree.

Awards: Awards will be presented at the opening reception on Friday, April 23, 2010 at the Center for the Arts Evergreen, 5-8 pm.

Judging: Artwork will be chosen from CDs submitted. No substitutions will be accepted. Please include a SASE with the entry form. Notification will be mailed by March 31, 2010. CD's will be returned to artists at show check-in or returned with non-acceptance letters.

Sales: Work sold during the exhibition is subject to 40% commission and must remain on display for the duration of the show. Payments to the artists will be made within 30 days after the close of show.

Delivery: Hand delivered work will be received at the Center for the Arts Evergreen April 18, 12-4 p.m. and April 19, 10-4 p.m. Shipped work (Fed Ex or UPS only) must be received by April 19th. Artists are responsible for all shipping costs. Shipping and delivery information will be provided upon acceptance.

Return of Artwork: Artists are responsible for picking up their work on Friday, May 21st, 12-4 pm or Saturday, May 22nd, 12- 4 p.m.
